# 6. National, Ladies & Junior Championships - Entry Fees

### 9. World Bowls Report

The Honorary Secretary referred to his report at the AGM. It was a case of what could have been as Ireland was runners-up in 3 out of the 4 disciplines. Alan Paul was runner-up in the World Singles title to Jonathan Payne of Belgium. Sean and Kevin Conroy lost out to Jonas and Joel Hager of Sweden in the pairs. Finally in the fours, DJ Wilson, Eddie Campbell, Jonny Wilson and Andrew Leckey lost in the final against Chris Willies' rink from England. T Haire, team manager, said that the dress code should be adhered to when travelling. It was put forward that if the players didn't turn up in the correct dress then they shouldn't be allowed to go.

# 10. AGM Report

The Hon Secretary reported that the attendance at the AGM was slightly better than last year. The affiliation fee for 2018/19 was raised to £30 and rule 37 had been amended to cover every end and not just the last end. View expressed thought that an explanation should be given at the AGM when increasing fees.

#### 13. Correspondence

i. A letter was received about an alleged incident that happened at the National Championships. Hon Secretary replied requesting the name of person involved. A further letter was received from the complainant who still withheld this information. Therefore the matter could not be taken any further.

### 14. Any other notified business

i. Insurance – t was stated stated that a lot of clubs don't know about Public Liability Insurance and that clubs in the Monaghan League must have their own insurance in order to play. He asked the Hon Treasurer if anything could be done as a group through the IIBA. The Hon Treasurer agreed to contact the IIBA's insurance company to ask if they could provide a quote for clubs.

It was indicated that the cost of Public Liability Insurance was £600 per club in Oriel. It was suggested trying Norris and Fisher who also provides insurance for bowling clubs.

- ii. Ditching Jacks –A discussion took place regarding the interpretation of Rule 37 by some umpires. Clarification needs to be sought regarding touchers by the lead.
- iii. T Haire asked if a club closed down did the 3 year rule with regards to playing in Inter Zone bowls affect the players if they wanted to return to their original Zone. It was proposed and seconded that this should be brought up at the next AGM.
