7. Competitions Secretary Reports

7.1 and 7.2 National Competitions and Interzone Competitions Update

The Competitions' Secretary indicated that these have been completed and as predicted the first day was very long as there a lot of duplications which led to delays, but everyone had been warned to expect this.

The schedule for 23 March is as follows:

9.30 am: All interzone finals followed by presentations.

2 pm approx.: Ladies Rinks, National Rinks & National Triples.

3.30 pm approx.: National Singles Semi-finals, Junior Pairs, Ladies Pairs, Ladies Triples, Over 55 Pairs.

4.30 pm approx.: National Singles, National Pairs, Ladies Singles, Junior Singles, Mixed Pairs. The presentations will follow at conclusion of these games.

A discussion then took place about the Interzone competitions: It was proposed and seconded that the Ladies Interzone Competition for 2024/25 be played at Shaws Bridge on one day up to the semi-final stage.

It was proposed and seconded that the Ladies Interzone Competition be played on a home and away basis. A vote took place and it was tied at 8 votes each. The Chair had the casting vote and voted for the first proposal.

It was proposed and seconded that the Mens Interzone Competition for 2024/25 be played at Shaws Bridge. It was proposed and seconded that the Mens Interzone Competition be played on a home and away basis. The vote was 13-2 in favour of a home and away basis.

It was also agreed that the Over 55 Interzone Competition be held on the same basis as the Ladies Interzone Competition i.e. played up to the semi-final stage at Shaws Bridge.

8. Location of Interzone finals

The location of Interzone finals was raised. It was felt that taking the teams to a neutral hall would generate more atmosphere. It was also added that having two teams playing in finals on the same day at the same time at the same venue made it impossible to support both teams. It was added that there should be separate days for the National Finals and the Interzone finals.

9. World Bowls Report

Gary McNabb won the singles title for Ireland, Jim Fox, Shane Hand and Paul Duff were runners-up in the triples while Adam Dyche, Trevor Brown and Charlie Clarke finished fourth. In the Fours, DJ Wilson, Eddie Campbell, Jonny Wilson and Andrew Leckey came third. The Honorary Secretary congratulated the other representatives who had performed well. The IIBA rules were adopted for the Championships and by the third day Rule 37 got quite a positive response by the players. The raffle which was looked after by Sammy Bates and Ruth Neely raised between £900-£1,000. Jean Parkinson was also thanked for sorting the name boards for every round. Last but by no means least our thanks go to our main sponsor Go whose generous sponsorship went a long way to making the Championships the success that they were.
